The Fence must have 5 feet of easement adjacent from each property line {this means you must build your fence 5 feet inside your property line so you do not intrude or trespass on your neighbor's property when installing and maintaining your fence}
- _____ Materials: (the covenants committee will review the type of material submitted, but no chain link fences are allowed).
- _____ Structure must not be visible from any street (must face inside toward yard).
- _____ Diagram of fence layout

_____ **Deck/Porch**

- _____ Picture or drawing (deck must match any existing deck).
- _____ Dimensions
- _____ Color (must be natural or painted to match exterior color of home).
- _____ Site plan denoting location (in most cases may not extend past sides of home).
- _____ Materials (must be cedar, cypress or No. 2 grade or better pressure-treated pine).

_____ **Shed/Outbuilding**

- _____ Must meet the minimum building requirements of the Fayette County Build codes.
- _____ Must be constructed to reflect the current appearance of the primary dwelling on the lot (i.e., color, brick or wood siding, shingled roof of approximate shape and pitch of the primary dwelling on the lot).
- _____ Must be constructed on a concrete slab/foundation.
- _____ Under no circumstances are metal or plastic structures permitted on any lot at any time.
- _____ Drawing of layout as to where the structure will be installed.
- _____ Must be out of sight from street view.
